2. This Opportunity is open to all residents in the UK over the age of 18 ("Eligible Participants"). By participating in the Opportunity, every Eligible Participant confirms they have read and agree to comply with these Terms and Conditions ("Terms"), Administrator's terms of use located at: <https://www.umusic.co.uk/terms.html>, the submission guidelines available on the Website ("Submission Guidelines") and all other requirements for partaking in this Opportunity.
